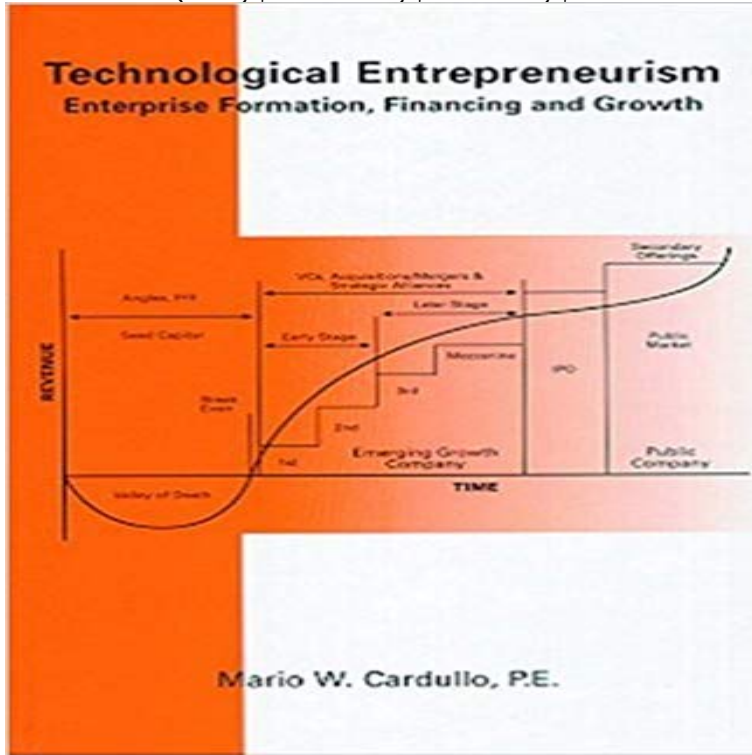


Technological Entrepreneurism: Enterprise Formation, Financing and Growth (Engineering Management Series)
