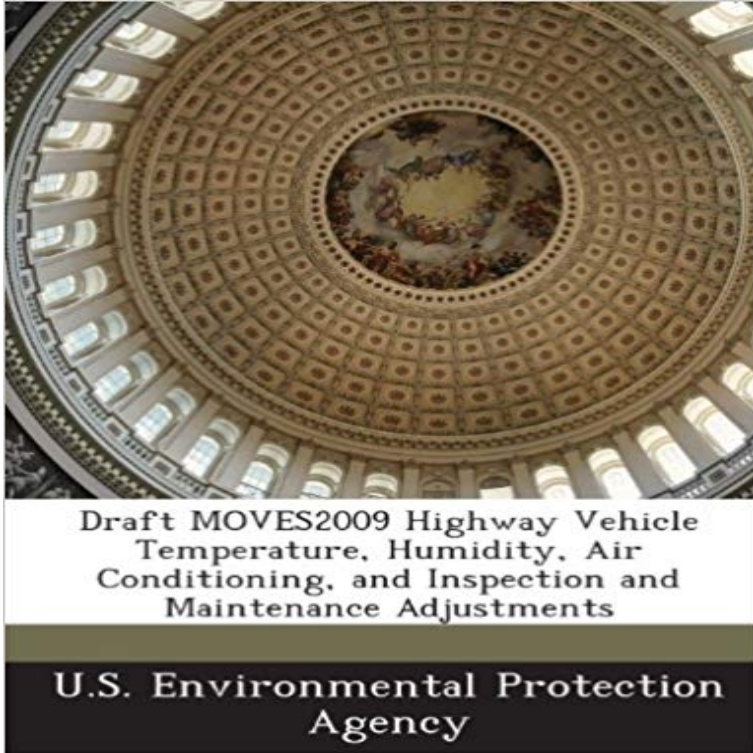


Draft MOVES2009 Highway Vehicle Temperature, Humidity, Air Conditioning, and Inspection and Maintenance Adjustments
