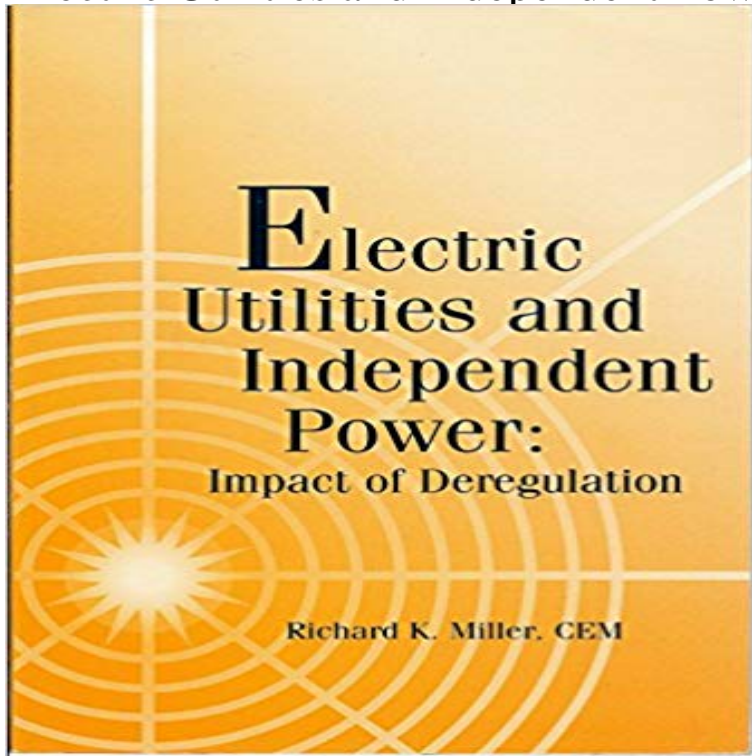


# Electric Utilities and Independent Power: Impact of Deregulation
