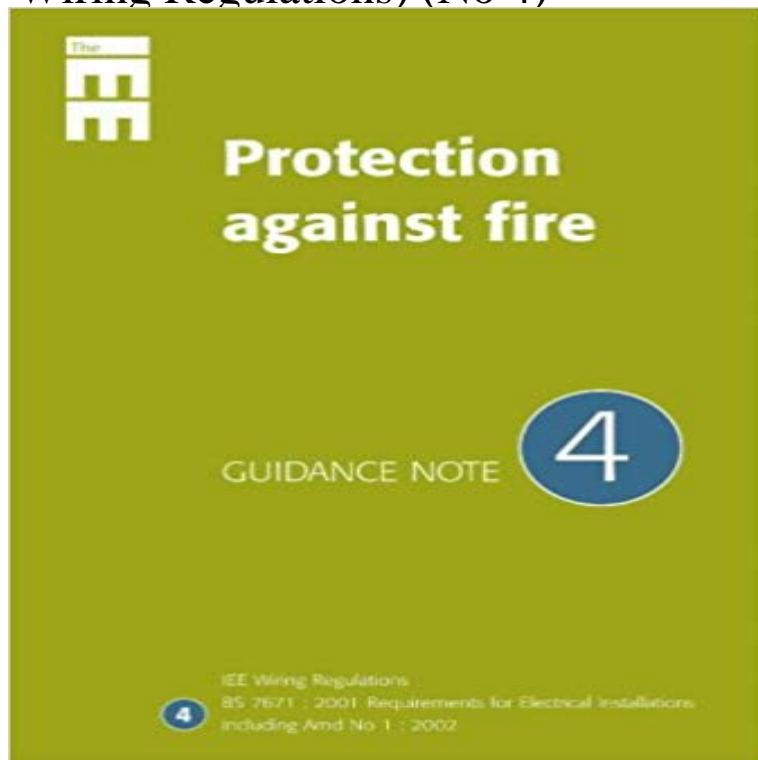


## Guidance Note 4: Protection Against Fire (IEE Guidance Notes) (IEE Wiring Regulations) (No 4)
