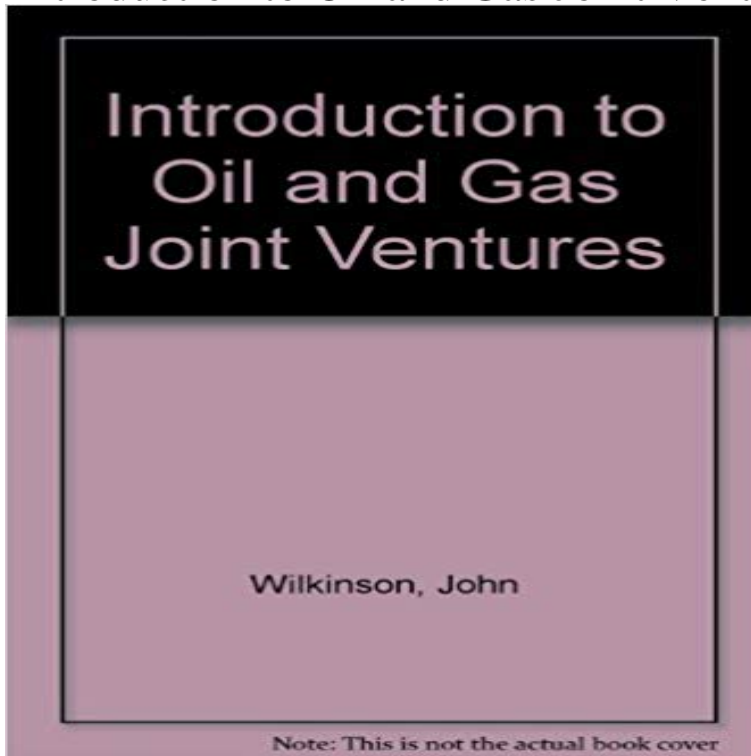


Introduction to Oil and Gas Joint Ventures

Production (operations facilities including use of FPSOs), pipelines, terminals and other responsibilities), Field Management (reservoir, costs end of life), Personnel, Safety, Transportation by tanker (ownership, revenue and costs). Transportation by pipeline (planning, viability and safety) Abandonment. Joint Venture agreements for associated services - Tankers (contacts or time and voyage charters, rights, legal aspects), Transportation of oil and gas by pipeline (agreements, terms, risks liabilities). Financing Economics, Tax, Safety, Insurances - Financing structures, risk allocation, farm-ins, economics and
