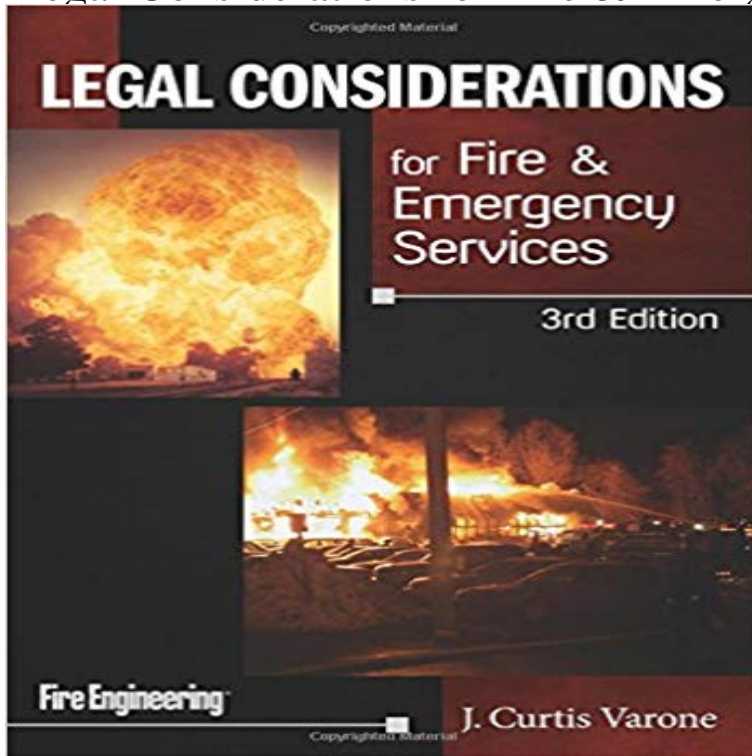


Legal Considerations for Fire & Emergency Services
