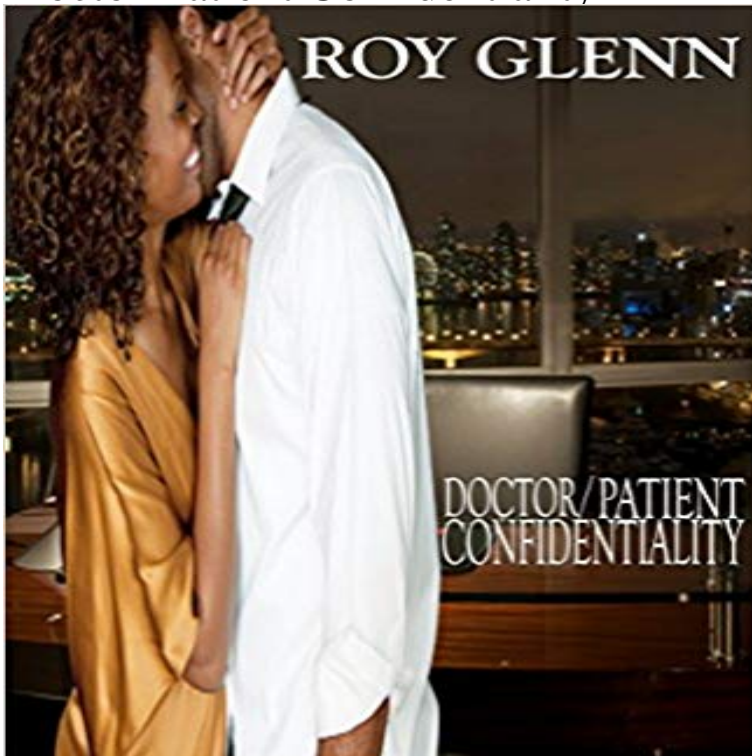


Doctor-Patient Confidentiality
