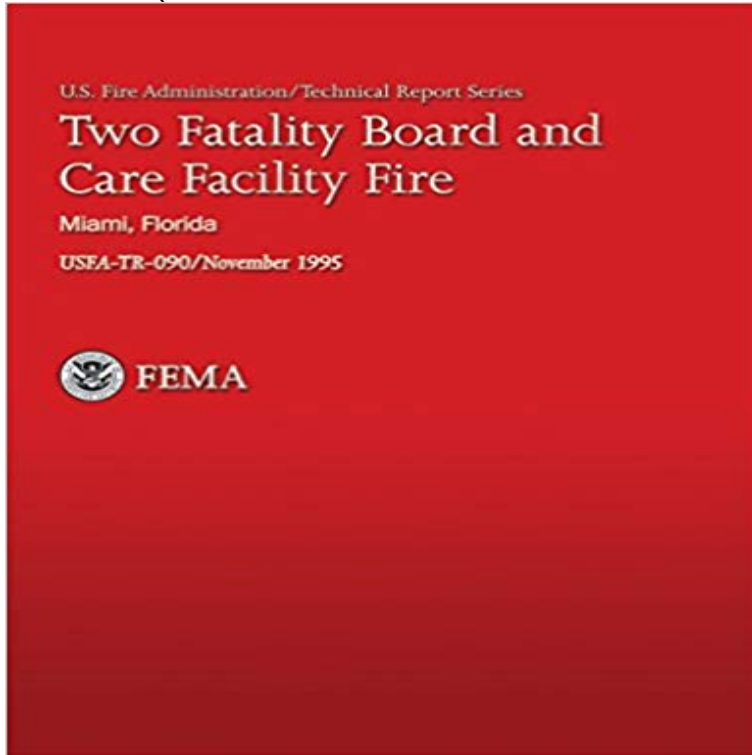


# Two Fatality Board and Care Facility Fire Salvation Army Rehabilitation Center (U.S. Fire Administration Technical Report 090)
