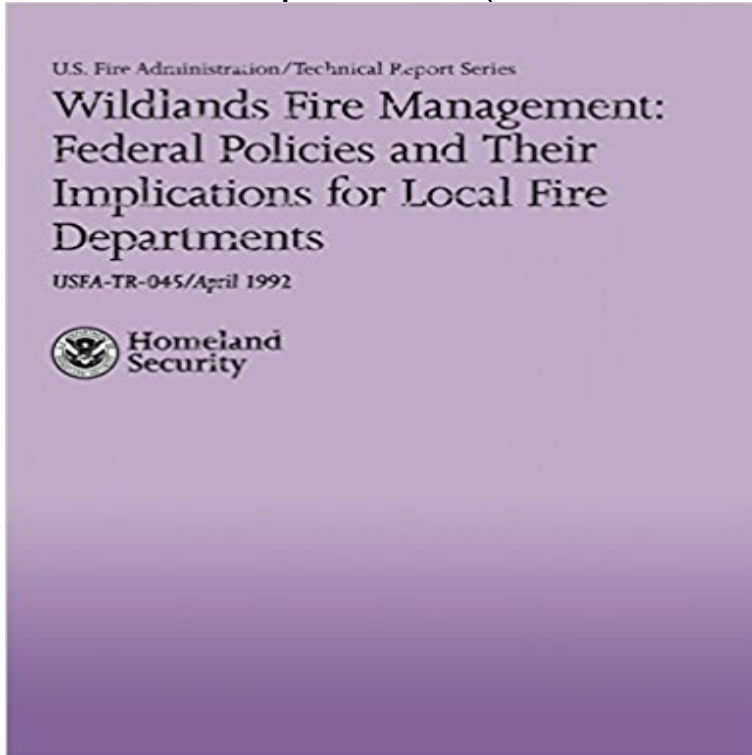


Wildlands Fire Management: Federal Policies and Their Implications for Local Fire Departments (U.S. Fire Administration Technical Report 045)
